Shall be subject to all rules and regulations of the competition, and agree to hold competition (hereinafter to include, without limitation: VT Morgan Heritage Days, The Vermont Morgan Horse Association, Inc., all landowners, and their officials, directors, trustees, members, volunteer workers, employees and agents) harmless for any action taken. 2. Represent that every horse, rider, driver and handler is eligibly as entered. 3.
